### NOTICE 49 OF 2011

#### MEDICINES AND RELATED SUBSTANCES ACT, 101 OF 1965

#### INFORMATION TO BE PROVIDED BY MANUFACTURERS AND OR IMPORTERS OF MEDICINES AND RELATED SUBSTANCES FOR THE SINGLE EXIT PRICE

I, Malebona Precious Matsoso, Director General, have determined in accordance with Regulation 21 of the Regulations Relating to a Transparent Pricing System for Medicines and Related Substances published in Government Gazette Number 28214 of 11 November 2005 that a complete schedule of medicine prices for all companies as of the 01 November 2010 was published on the Department of Health website.


Licensed manufacturers and or importers of medicines or scheduled substances were advised that should there be any errors, omissions or discrepancies in their schedule, they must have these resolved with the Directorate: Pharmaceutical Economic Evaluation (PEE) by no later than 15 November 2010.

Submissions for such corrections should have been provided in electronic (Excel with an xls filename extension on a labeled disc) and a hard copy. The submissions should have been addressed and hand delivered to:

The submissions should have been in the same format in which it was published on the website. The Directorate would have responded to all submissions and queries within 14 working days of receipt of such correspondence.
